Promoters / Promoters group encumbrance includes the following: (i) (A) pledge of certain shares in favour of YES Bank Limited; (B) pledge of certain shares in favour of Vistra (ITCL) India Ltd and (C) pursuant to a financing arrangement amongst Namit Malhotra, A2R Holdings, Mauritius (an entity wholly owned by Namit Malhotra) and Novator Capital Limited, (i) a pledge has been created over Namit Malhotras entire shareholding in A2R Holdings, in favour of Novator Capital Limited and A2R Holdings hold 44.26% equity shares of the Company; and (ii) the members of the promoter and promoter group of the Company are, except as permitted under such financial arrangement/consented by Novator Capital Limited, are restricted from: (a) disposing of their shareholding in the Company; (b) ceasing control over the Company; and (c) creating any further encumbrance over the equity shares of the Company.
