Re: Rating Letter for BLR of Prime Focus Limited

India Ratings and Research (Ind-Ra) has placed Prime Focus Limited's (PFL) Long-Term Issuer Rating of 'IND BBBi Rating Watch Positive (RWP). The Outlook was Stable. The instrument-wise rating actions are as follows:
